3:0 FUNCTIONS AND DUTIES-THE TEACHING AND LEARNING COACHES SERVES AS A MEMBER OF A TEAM THAT FACILITATES AND DRIVES THE DISTRICT'S TEACHING AND LEARNING SYSTEM FOR ALL STUDENTS THAT INCLUDES THE DISTRICT'S CORE CURRICULUM, COMMON ASSESSMENTS, UNIVERSAL INSTRUCTIONAL PRACTICES, DATA TEAMS AND PROFESSIONAL DEVELOPMENT.

3:1 CURRICULUM, ASSESSMENT AND PROFESSIONAL DEVELOPMENT

- 3:1.1 Receives curriculum documents (curriculum guide) that contains the core curriculum benchmarks, resources, timelines, articulation maps, and common assessments that are in alignment with the state frameworks.
- 3:1.2 Contributes to the development of appropriate professional development activities and programs in accordance with instructional program content; student, teacher, and administrative needs indicated by programs curriculum, assessments, and district goals.

- 3:3.1 Compile, organize and clearly articulate classroom, grade level and school data. Facilitates teacher team's data driven dialogue and supports data driven instructional adjustments.

- 4:1.3 The Teaching and Learning Coaches expresses him/herself clearly and confidently orally and in writing; capable of responding effectively in a public forum.
- 4:1.4 The Teaching and Learning Coaches builds caring and considerate relationships that demonstrate regard and respect for all people.
